The Run will start and finish at Salisbury Livestock Market, Netherhampton, Salisbury SP2 8RH Assemble from 9.30am for move off at 10.30am to end with a static display in the early afternoon. There are no official stops, a day to enjoy yourself driving your pride and joy. Salisbury Plain Route as last year, approximately 75 miles.

### Conditions of Entry:

- There will be no classes or awards.
- The event is open to all forms of commercial vehicle, large or small, including public service vehicles, aged 20 years and over. Newer vehicles at the discretion of the organisers.
- All vehicles must be presented in a clean, complete and safe legal working condition. **No Trade Plates.**
- Anyone you nominate to move, drive, control or otherwise operate the vehicle must be competent to do so and have a valid driving licence.
- The vehicle must be covered by insurance as required by law including Public Liability having an indemnity of not less than £2,000,000.
- The organisers reserve the right to refuse any entry for any reason; the decision of the committee will be final.
- Entrants must pay due regard to all marshals instructions remembering the good name of CTP at all times.
- No transporters will be allowed on the route except if required for a genuine breakdown.
